

TERMINATION AND RELEASE OF SECURITY AGREEMENT

This TERMINATION AND RELEASE OF SECURITY AGREEMENT (this "Termination and Release") is granted as of January 21, 2020 by Silicon Valley Bank ("Secured Party"), in favor of EYEVIEW, INC., a Delaware corporation (the "Grantor").

- authorizes and requests that this Termination and Release be recorded with the USPTO;

- 4. agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the liens on and security interests in the Trademarks contemplated hereby.
