**PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST**

This Partial Release of Trademark Security Interest (this "Partial Release") is effective as of January 23, 2020, by and between Affinity Gaming, a Nevada corporation (the "Grantor") and Credit Suisse AG, Cayman Islands Branch ("Credit Suisse"), as Collateral Agent (the "Agent") for the Secured Parties (as defined in the Credit Agreement described below). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Credit Agreement (as described below).

WHEREAS, pursuant to that certain Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), dated as of July 1, 2016, by and among the Grantor, Affinity Gaming Owner, L.L.C. (f/k/a Z Capital Affinity Owner, LLC), a Delaware limited liability company, Credit Suisse, as administrative agent and Agent, and the other parties from time to time party thereto, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Grantor executed and delivered that certain Grant of Security Interest in Trademarks (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), dated as of July 1, 2016 by Grantor in favor of Agent;

WHEREAS, pursuant to said Trademark Security Agreement, the Grantor granted to Agent, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under its United States trademarks, including but not limited to those listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent & Trademark Office on July 1, 2016, at Reel/Frame 5826/0799;


WHEREAS, in connection with a disposition of the Trademarks listed on Schedule A that is permitted by the Credit Agreement, Agent wishes to release its security interest in the Trademarks listed on Schedule A only and retransfer and reassign to the Grantor without recourse all of Agent's right, title and interest in and to the Trademarks listed on Schedule A.


