

#### RELEASE OF TRADEMARK SECURITY AGREEMENT

Releasor, without any representation, warranty or recourse of any kind, on behalf of itself and the Secured Parties, hereby (i) terminates, releases, cancels, relinquishes and discharges its and the Secured Parties' security interest in the Collateral, including without limitation, all of Releasor's right, title and interest in and to the Collateral listed on Schedule A to the Agreement, as well as any other lien or security interest Releasor or any Secured Party may have in the Collateral or any other collateral of Releasee under the Agreement, (ii) terminates the Agreement and (iii) hereby reassigns any and all such right, title and interest that the Releasor or any Secured Party may have in, to or under the Collateral, together with the goodwill of the business symbolized thereby, to the Releasee.
- 3. <u>Authorization</u>. Releaseor hereby authorizes Releasee or Releasee's agent to record this Release with the United States Patent and Trademark Office.
