RELEASE OF SECURITY INTEREST IN TRADEMARKS

Dated as of September 15, 2016

Northside Media Holdings, LLC, a New York limited liability company ("Grantor"), executed that certain Trademark Security Agreement, dated November 25, 2015 (the "Security Agreement"), in favor of White Oak Global Advisors, LLC, a Delaware limited liability company ("White Oak"), pursuant to which Grantor granted, pledged, and assigned to White Oak, as administrative agent for certain lenders ("Lenders") that were parties to that certain Loan and Security Agreement, dated November 25, 2015, as amended, by, between, and among Grantor, White Oak, and various third parties (the "Loan Agreement"), a security interest in all right, title, and interest in and to Grantor's trademark and service mark rights, trademark and service mark registrations, and applications therefor, including those specific trademark registrations set forth on Schedule A, attached hereto and incorporated herein by reference (collectively, the "Released Marks"), and all goodwill associated therewith. The Security Agreement was recorded on December 1, 2015, at Trademark Reel/Frame 005679/0051 in the United States Patent and Trademark Office.

Pursuant to that certain Asset Purchase Agreement, dated September 16, 2016, by and between Grantor and Northside Media, Inc., a Delaware corporation ("Northside"), Grantor sold and assigned to Northside all of Grantor's right, title, and interest in and to certain assets, including the Released Marks. Pursuant to that certain Consent to Sale and Release and Termination of Liens executed by White Oak on September 15, 2016 on its own behalf and on behalf of all Lenders ("Termination of Liens"), any and all liens granted to White Oak and the Lenders were automatically and irrevocably terminated and released.


Pursuant to Section 4 of the Termination of Liens, White Oak, on behalf of itself, its successors, legal representatives, assigns, and all Lenders, is now delivering this Release of Security Interest in Trademarks to Northside for recordation with the United States Patent and Trademark Office, effective as of the date first set forth above, to evidence the full release, termination, and discharge of its security interest in the Released Marks and the goodwill associated therewith, and the transfer to Northside, free and clear of any claims by White Oak, all of White Oak's right, title, and interest in and to the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any.






