WHEREAS, Assignor owns rights in the U.S. federal and state trademarks on the attached **Schedule A** (hereinafter referred to as the "Trademarks");



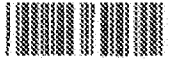
