**FIRST:** That the Board of Directors of Sonus Networks, Inc. has duly adopted resolutions by unanimous written consent setting forth a proposed amendment of the Certificate of Incorporation of the Corporation (the "Amendment"), declaring said Amendment to be advisable and calling for the sole stockholder of the Corporation to consider the proposed name change. The resolution setting forth the proposed Amendment is as follows:

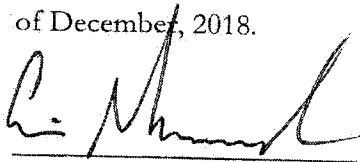
"The name of the corporation (the "Corporation") is **Ribbon Communications Operating Company, Inc.**"
