TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of January 27, 2020 by SILICON VALLEY BANK (the "*Bank*"), in favor of THOUGHTONOMY LTD, registered in England & Wales with registration number 08534024 (the "*Grantor*").

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement, dated as of October 5, 2018, as amended by a First Amendment to Intellectual Property Security Agreement, dated as of March 19, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting the Bank a security interest in and lien on certain trademarks and trademark applications ("*Trademarks*") described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on October 5, 2018, at Reel 6488, Frame 0820;

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks (as defined in the Agreement) (collectively, the "*Trademark Collateral*") as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:


1. terminates the Agreement and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE COMMONWEALTH OF MASSACHUSETTS.
