RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS, effective as of January 24, 2020 given by CIBC BANK USA, in its capacity as administrative agent for the Lenders (in such capacity, the "Administrative Agent"), with principal offices at 120 S. NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby terminates, releases, and discharges unto Grantor the continuing security interest in, and any other interest Administrative Agent may have in Grantor's right, title and interest in, the Trademark Collateral.
