INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("**IP Assignment**"), dated as of December 17, 2019, is made by DIVERSEY US HOLDINGS, LLC ("**Diversey LLC**") in favor of DIVERSEY INC. ("**Diversey**").

WHEREAS, Diversey LLC was the purchaser of certain assets of Vendors pursuant to a **PURCHASE AGREEMENT** between, among others, Diversey LLC and Virox Technologies Inc., Virox Holdings Inc., Virox Holdings International Inc. and Virox International Inc. dated December 17, 2019 (the "**Purchase Agreement**").

WHEREAS, Diversey LLC has determined to make a distribution to Diversey, its sole member, that is to be payable by the transfer by Diversey LLC to Diversey of the assets acquired by it pursuant to the Purchase Agreement (the "**Distribution**") and, in connection with such Distribution, Diversey LLC and Diversey have agreed to execute and deliver this IP Assignment for recording such ownership change with the corresponding entities or agencies in any applicable jurisdictions where acquired intellectual property rights are applied for, registered, or granted;

NOW THEREFORE, the parties agree as follows:

1. Assignment. In furtherance of the Distribution and for such other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Diversey LLC hereby irrevocably convey, transfer, and assign to Diversey, and Diversey hereby accepts, all of Diversey LLC's right, title, and interest in and to the following (the "**Assigned IP**"):

(a) the issued patents and patent applications set forth on the individual country/jurisdiction Schedules listed in Exhibit 1 hereto and the inventions represented thereby, and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations, and renewals thereof, together with the right to claim priority in all foreign countries in accordance with international treaties and conventions, and all rights corresponding to said Patents in foreign countries throughout the world; (the "**Patents**");

(b) the trademark registrations, trademark applications, and common law trademarks set forth on the individual country/jurisdiction Schedules listed in Exhibit 2 hereto and all issuances, extensions, and renewals thereof (the "**Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

(c) all rights of any kind whatsoever of Diversey LLC accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(d) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief, including the right to sue for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages; all to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

2. Recordation and Further Actions. Diversey LLC hereby authorizes the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Diversey. Following the date hereof, Diversey LLC and its successors, assigns, and legal representatives shall take such steps and actions, and provide such cooperation and assistance to Diversey and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of the Assigned IP to Diversey, or any assignee or successor thereto.

3. Terms of the Purchase Agreement. The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Diversey LLC and Diversey with respect to the Assigned IP.

4. Counterparts. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.


5. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


