**NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of January 27, 2020, is made by **MIDCAP FUNDING IV TRUST**, a Delaware statutory trust and successor by assignment from MidCap Funding X Trust, in its capacity as Agent for the Lenders party to the Credit Agreement (defined below) (together with its successors and assigns, "Grantee"), and is as follows:

WHEREAS, **MULTIBAND FIELD SERVICES, INCORPORATED**, a Delaware corporation ("Grantor"), and Grantee are parties to that certain Trademark Security Agreement dated as of June 9, 2017, recorded with the United States Patent and Trademark Office on February 22, 2019 in its records at Reel 6570 Frame 0489 (the "Agreement"). Capitalized terms used but not defined herein will have the meaning given to them in the Agreement.

WHEREAS, the Agreement granted and assigned to Grantee a security interest in all of the Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement), including the following (the following collectively referred to herein as the "**Released Trademark Collateral**"): (a) each Trademark License and Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and (b) all products and proceeds of the forgoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark, or (ii) injury to the goodwill associated with any Trademark.

WHEREAS, Grantee desires to release its rights and security interests in the Released Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantee hereby releases and terminates, without any representation, recourse or undertaking, its security interest and other rights in, to and under the Released Trademark Collateral.


