The spin-off and thereby the assignment, transfer and conveyance to Assignee all of the rights, titles and interests stated above, became effective on December 1, 2017 with the registration of the spin-off in the commercial register of the Assignor (according to the German law applicable, sec. 133 para 1 GMA).

NOW THEREFORE the Assignor hereby confirms the spin-off, assignment, transfer and conveyance to Assignee of all of its rights, titles and interests in and to the trademarks in the USA, including the applications therefore and together with all goodwill attaching thereto, effective as of and from December 1, 2017, and as a matter of precaution – does hereby repeat the assignment, transfer and conveyance.
