**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of January 27, 2020 (“Effective Date”), by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as administrative agent for the Secured Parties (in such capacity, together with its successors and assigns, in such capacity, “Agent”), in favor of **CRC HOLDCO, LLC**, a Delaware limited liability company, (formerly known as CRC Holdco Corporation), and **CURRICULUM ASSOCIATES, LLC**, a Massachusetts limited liability company, (each of the foregoing, a “Grantor”; and collectively, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below) or, if not defined therein, in the Credit Agreement (as defined below).

**WHEREAS**, reference is made to that certain Credit Agreement, dated as of February 28, 2018 (as amended by that certain Amended and Restated Credit Agreement, dated as of September 18, 2019, by and among the Grantors, Agent and certain other parties thereto, as further amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Amended and Restated Credit Agreement”), by and among the Grantors, Agent and certain other parties thereto (the “Credit Agreement”);

**WHEREAS**, pursuant to the Credit Agreement, the Grantors and Agent entered into that certain Security Agreement dated as of February 28, 2018 (as amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the “Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, the Grantors and Agent entered into (i) that certain Trademark Security Agreement, dated as of February 28, 2018, which was recorded with the United States Patent and Trademark Office, (the “USPTO”) on February 28, 2018 at Reel 6281, Frame 0349; (ii) that certain Trademark Security Agreement, dated as of June 28, 2018, which was recorded with the USPTO on July 3, 2018 at Reel 6370, Frame 0956; (iii) that certain Trademark Security Agreement, dated as of April 30, 2019, which was recorded with the USPTO on May 8, 2019 at Reel 6640, Frame 0926; (iv) that certain Trademark Security Agreement, dated as of May 14, 2019, which was recorded with the USPTO on May 15, 2019 at Reel 6646, Frame 0265; and (v) that certain Trademark Security Agreement, dated as of September 18, 2019, which was recorded with the USPTO on September 18, 2019 at Reel 6748, Frame 0815 (each as amended, restated, amended and restated, supplemented, or otherwise modified and in effect from time to time, collectively, the “Trademark Security Agreements”);

**WHEREAS**, pursuant to the terms of the Trademark Security Agreements, each Grantor granted, assigned, and pledged to Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a continuing security interest in all of such Grantor’s right, title, and interest in and to all of its Trademarks, whether then owned or thereafter acquired or arising, including without limitation those Trademarks listed on **Schedule I** attached hereto (the “Trademark Collateral”); and

**WHEREAS**, Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule I** hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:



Terminates, releases, and, discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreements, and reassigns to each Grantor all right, title, and interest that Agent may have in the Trademark Collateral pursuant to the Trademark Security Agreements; and

2. Agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts, in each case at the Grantors expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
