## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** is dated as of the 2<sup>nd</sup> day of December, 2019 between **MCGREGOR INDUSTRIES INC. ("McGregor")** and **AMERICAN ESSENTIALS INC. ("AE")**, and together with McGregor, collectively "**Assignors**") and **PVH LEGWEAR LLC ("Assignee")**.

### **RECITALS:**

- A. The Assignors are the owners of certain Trademarks and Trademark Rights as more fully identified on Schedule "A" annexed hereto (such trademarks set out in Schedule "A", the "**Assigned Trademarks**");
- B. Pursuant to an asset purchase agreement made as of the 3<sup>rd</sup> day of July, 2019 between the Assignors, American Essentials International Limited and the Assignee (the "**Purchase Agreement**"), the Assignors have agreed to transfer all of their respective rights, title, and interests in and to the Assigned Trademarks to the Assignee upon and subject to the terms and conditions set out in the Purchase Agreement; and
- C. Capitalized terms used but not defined herein shall have the respective meanings ascribed to such terms in the Purchase Agreement.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and agreements hereinafter contained, the payment of the consideration stipulated in the Purchase Agreement and for other good and valuable consideration (the receipt and sufficiency of which are acknowledged by each party), the parties hereto agree as follows:

1. **Recitals.** Each of the Assignors hereby covenants and agrees that the recitals to this Trademark Assignment are true in substance and in fact and are hereby incorporated into, and form an integral part of, this Trademark Assignment.
2. **McGregor Trademark Assignment.** McGregor hereby sells, assigns, and transfers unto the Assignee all of its right, title and interest in and to:
  - (a) the Assigned Trademarks owned by McGregor (the "**McGregor Trademarks**"), including all applications, registrations and filings for the McGregor Trademarks that have been registered, filed, certified or otherwise perfected or recorded with or by any Governmental Authority or quasi-public legal authority anywhere in the world, including the United States Patent and Trademark Office, that are registered or recorded in the name of, are or were filed or recorded in the name of, or that have been assigned to, McGregor;
  - (b) the goodwill of the Business symbolized by the McGregor Trademarks; and
  - (c) all claims for damages by reason of past infringement of the McGregor Trademarks, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, and other legal representatives.

3. **AE Trademark Assignment.** AE hereby sells, assigns, and transfers unto the Assignee all of its right, title and interest in and to:
  - (a) the Assigned Trademarks owned by AE (the "**AE Trademarks**"), including all applications, registrations and filings for the AE Trademarks that have been registered, filed, certified or otherwise perfected or recorded with or by any Governmental Authority or quasi-public legal authority anywhere in the world, including the United States Patent and Trademark Office, that are registered or recorded in the name of, are or were filed or recorded in the name of, or that have been assigned to, AE;
  - (b) the goodwill of the Business symbolized by the AE Trademarks; and
  - (c) all claims for damages by reason of past infringement of the AE Trademarks, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, and other legal representatives.
4. **Non-Merger.** The provisions hereof shall not merge in or be superseded by and shall survive (to the extent provided for in the Purchase Agreement) the completion of the transactions provided for in the Purchase Agreement.
5. **Conflict.** If there is any conflict between the provisions of this Trademark Assignment, on the one hand, and the provisions of the Purchase Agreement, on the other, the provisions of the Purchase Agreement shall prevail, as the case may be.
6. **Further Assurances.** Each of the parties hereto shall promptly do, make, execute, deliver, or cause to be done, made, executed or delivered, all such further acts, documents and things as the other party hereto may reasonably require from time to time for the purpose of giving effect to this Trademark Assignment.
7. **Enurement.** This Trademark Assignment shall enure to the benefit of and shall be binding on and enforceable by the parties and their respective successors and permitted assigns, as the case may be.
8. **Governing Law.** This Trademark Assignment shall be construed in accordance with the laws of the State of New York and shall be treated, in all respects, as a New York contract.
9. **Counterparts.** This Trademark Assignment may be executed in any number of counterparts, and/or by facsimile or PDF file, each of which constitute an original and all of which, when taken together, shall constitute one and the same instrument.


