TRADEMARK ASSIGNMENT AGREEMENT
Ultratech, Inc. to Veeco Instruments Inc.

This Trademark Assignment (the "Assignment") is made as of December 24, 2019, by and between Veeco Instruments Inc. ("Veeco"), a company incorporated in the State of Delaware, and Ultratech, Inc. ("Ultratech"), a company incorporated in the State of Delaware.

WHEREAS, Ultratech is the sole and exclusive owner of the entire right, title and interest in, to and under the United States trademark registrations and applications listed in Appendix A attached hereto, including any common law trademark rights therefor (the "Marks") together with the goodwill of the Marks; and

WHEREAS, Veeco is desirous of obtaining all right, title and interest in and to the Marks together with the goodwill of the Marks; and

WHEREAS, Ultratech is agreeable to assigning the Marks together with the goodwill of the Marks to Veeco.

NOW, THEREFORE, for good and valuable consideration paid by Veeco to Ultratech, the receipt and sufficiency of which is hereby acknowledged, Ultratech does hereby sell, assign, transfer and set over to Veeco, Ultratech's entire right, title and interest in and to the Marks, together with the goodwill of the Marks, for the United States and for all foreign countries, including any renewals or extensions thereof that are or may be secured under the laws of the United States or foreign countries now or hereafter in effect and including the subject matter of all claims which may be obtained therefrom for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Ultratech if this Assignment and sale had not been made; together with all income, royalties or payments due or payable as of the effective date of this Assignment or thereafter, including all claims for damages by reason of past, present or future infringement or other unauthorized use, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

This Agreement shall be construed in accordance with and governed by the laws of the State of Delaware, excluding any choice of law rules which direct the application of the laws of another jurisdiction.
