DECLARATION OF TRUSTEES OF THE  
ZAPPA FAMILY TRUST DESCENDANTS TRUST  
REGARDING NAME CHANGE OF THE TRUST

July 8, 2019

WHEREAS, Ahmet Zappa and Diva Zappa are the designated and acting Trustees of the Zappa Family Trust Descendants Trust, created under the Zappa Family Trust u/t/d November 15, 1990, as the successor-in-interest to the Zappa Family Trust Survivors Trust and the Zappa Family Trust Administrative Trust (collectively the "Trust");

WHEREAS, Part 5.08 P. of the Trust, as amended by the Fifth Amendment thereto dated May 28, 2014, provides as follows:

"5.08 P Power to Change Name. The Trustee shall have the power, in the Trustee's sole and absolute discretion, to name, rename or change the name of the Trust or any trust created hereunder."

WHEREAS, the Trustees desire to change the name of the Zappa Family Trust Descendants Trust to the Zappa Trust.

NOW THEREFORE, THE TRUSTEES RESOLVE AND DECLARE that the Trust formerly referred to as the Zappa Family Trust Descendants Trust shall hereinafter be known as the "Zappa Trust".

This Declaration of Trustees shall be effective as of the date first above written.
