Termination and Release of Patent and Trademark Security Agreement

This Termination and Release of Patent and Trademark Security Agreement ("Release") is made as of January 31, 2020, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association ("Wells Fargo"), in favor of AVKARE, INC., a Tennessee corporation ("Debtor").

WITNESSETH:

WHEREAS, the Debtor entered into a patent and trademark security agreement dated June 26, 2012 (the "IP Security Agreement") with Wells Fargo, notice of which was recorded on June 27, 2012 at the United States Patent and Trademark Office at Reel 4809, Frame 0249.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.


