TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Agreement") is dated as of April 25, 2017 (the "Effective Date") and entered into by and among Rock Bottom Restaurants, Inc., a Delaware corporation ("Assignor"), and Gina Day ("Assignee"), pursuant to that certain Termination, Assignment of Claims, and Assignment of Trademarks Agreement dated as of the Effective Date (the "Termination Agreement") by and between Assignor and Assignee, and the other parties thereto. Initially capitalized words or terms used in this Agreement but not defined herein have the respective meanings given to them in the Termination Agreement.

RECITALS

Pursuant to the Termination Agreement, Assignor desires to assign to Assignee all of Assignor's right, title, and interest in and to the trademarks as set forth on Schedule A attached hereto, together with the goodwill pertaining thereto (collectively, the "Trademarks").

NOW, THEREFORE, in reliance on the representations and warranties, and in consideration of the mutual promises and agreements contained in this Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment of Trademark Rights. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, transfers and assigns unto Assignee, effective as of the Effective Date, all right, title and interest in and to the Trademarks owned by Assignor, including without limitation, any and all goodwill and all common law rights, including any and all legal and equitable causes of action for any past, present or future infringement, such Trademarks to be held and enjoyed by Assignee and its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

2. Further Assurances. Upon the reasonable request of any party, the parties shall on and after the Closing Date execute and deliver, or cause to be executed and delivered, all further instruments and assurances and take any further acts as may be reasonably requested by any party and as are required to effectuate completely the assignment of the Trademarks as contemplated by this Agreement.

3. Governing Law; Venue. This Agreement shall be governed by, and construed in accordance with, the laws of State of Colorado, without regard to conflicts-of-laws principles that would require the application of any other law. The courts of the State of Colorado shall have jurisdiction in respect of any dispute, controversy or claim arising out of or in connection with this Agreement.

4. Execution of Agreement. This Agreement may be executed in two or more counterparts, each of which shall be deemed to be an original copy and all of which, when taken together, shall be deemed to constitute one and the same agreement. The exchange of copies of this Agreement and of signature pages by facsimile transmission shall constitute effective

execution and delivery of this Agreement as to the parties hereto, and may be used in lieu of the original Agreement for all purposes. Signatures of the parties transmitted by facsimile shall be deemed to be their original signatures for all purposes.
