## TRADEMARK CONFIRMATORY ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (the "Assignment"), is made by and between Agent Extra, LLC ("Assignor"), a Texas limited liability company, having a place of business in Katy, Texas, and CERT Holdings, LLC ("Assignee"), a Texas limited liability company, having a place of business in Katy, Texas.

**WHEREAS**, Assignor owned the entire right, title and interest in, to and under the trademark BACKAGENT, USRN 3,705,859, (the "Trademark"), together with the goodwill of the business activity symbolized by the Trademark and all common law rights to the Trademark;

**WHEREAS**, the Intellectual Property Assignment Agreement in Exhibit D of the Membership Purchase Agreement dated January 30, 2018 by, between and among Cert Holdings, LLC, Agent Extra, LLC, and Boston Logic Technology Partners, Inc. ("Previous Assignment") purported to assign the entire right, title and interest in, to and under the trademark BACKAGENT, USRN 3,705,859, (the "Trademark");

**WHEREAS**, the Previous Assignment did not, on its face, expressly assign the goodwill of the business activity symbolized by the Trademark and all common law rights to the Trademark to Assignee, although that was the intent of both Assignor and Assignee; and

**WHEREAS**, Assignee and Assignor desire that the entire right, title and interest of Assignor in and to the Trademark along with the goodwill of the business activity symbolized by the Trademark and all other rights appurtenant thereto be vested in Assignee via a written agreement.

**NOW, THEREFORE**, in consideration of the above-stated premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties intending to be legally bound agree as follows:

To the extent not already assigned, Assignor does hereby sell, assign, transfer and deliver to Assignee, its successors, assigns and legal representatives, its full and exclusive right, title and interest in and to the Trademark, together with the goodwill of the business activity symbolized by the Trademark and associated therewith, and all other common law rights, and the right to recover for damages and profits for past infringements of the Trademark.

Assignee hereby accepts all right, title and interest assigned by Assignor.

This assignment shall be binding upon Assignor's successors, assigns and legal representatives, and shall inure to the benefit of Assignee, its successors, assigns and legal representatives, as the case may be.

Assignor further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in Assignee, its successors, assigns and legal representatives.

The parties agree that the effective date of this Trademark Confirmatory Assignment is January 30, 2018.
