## NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Notice of Release**”) is made as of February 3, 2020, by BARCLAYS BANK PLC, in its capacity as administrative agent (in such capacity, the “**Administrative Agent**”) for the Secured Parties (as defined in the Security Agreement (as defined below)), in favor of PEROXYCHEM ADVENTUS ENVIRONMENTAL SOLUTIONS LLC (the “**Grantor**”).

WHEREAS, the Grantor and Administrative Agent are party to that certain Security and Pledge Agreement dated as of October 1, 2019 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the “**Security Agreement**”), whereby the Grantor granted to the Administrative Agent for the benefit of the Secured Parties a continuing security interest in, and a right of set off against, any and all right, title and interest of the Grantor in and to each of the trademarks and trademark applications shown on Schedule 1 attached hereto (collectively, the “**Trademark Collateral**”);

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of October 1, 2019 (the “**Trademark Security Interest Notice**”), the Grantor confirmed such grant of security interest;

WHEREAS, the Trademark Security Interest Notice was recorded with the United States Patent and Trademark Office on October 2, 2019 at Reel/Frame 6829/0468; and

WHEREAS, the Grantor has requested that the Administrative Agent execute and deliver this Notice of Release to evidence the release of its security interest in the Trademark Collateral for recordation with the United States Patent and Trademark Office.


