## TRADEMARK AND DOMAIN NAME ASSIGNMENT

This Trademark and Domain Name Assignment (this "*Assignment*") is made and entered into as of December 17, 2019, by and between Diffeo, Inc., a Delaware corporation ("*Assignor*") and salesforce.com, inc., a Delaware corporation ("*Assignee*").

Assignor assigns to Assignee and its successors and assigns, and Assignee accepts from Assignor, all of Assignor's right, title and interest in the Assigned Trademarks and Domains, including, without limitation, all common law trademarks for which no applications or registrations exist, all applications to register any of the Assigned Trademarks and Domains, and all registrations that have been or may be granted for any of the Assigned Trademarks and Domains, together with all common law rights associated with the applications and registrations, and all goodwill associated with the Assigned Trademarks and Domains and symbolized thereby, along with that portion of the business which is ongoing and existing to which the Assigned Trademarks and Domains pertain, together with the right to sue and recover damages for future, present, and past infringements of the Assigned Trademarks and Domains and to fully and entirely stand in the place of Assignor in all matters related to the Assigned Trademarks and Domains.

2. Further Assurances.

a. Assignor agrees to execute and deliver such other documents and to take all such other actions which Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment, and to execute and deliver any and all documentation as may be reasonably required to effect the terms of this Assignment and its recordation in relevant state and national trademark offices.

b. Assignor represents that Assignor has the right, title, and interest to assign as set forth herein, and covenants with Assignee that Assignor has not made and will not hereafter make any assignment, grant, mortgage, license, or other agreement affecting the right, title, and interest herein assigned.


