The undersigned, being the surviving corporation of the merger herein describe, files these Articles of Merger pursuant to Ala. Code §10-2B-11.05, and as required by said statute, sets forth and states the following:

1. The Plan of Merger approved by the corporations is as follows:

A. The name of the merging corporations and their places of incorporation are:
