## RELEASE OF SECURITY INTEREST IN TRADEMARKS

1. This Release confirms that the entire security interest and all other rights and interests granted to Grantee under the Security Agreement in and to the Trademarks are released and permanently terminated to the extent that any security interest was granted to Grantee by the Security Agreement.

2. This Release is intended to be recorded in the U.S. Patent and Trademark Office or any other trademark office(s) as desired to confirm and evidence the foregoing release and termination of the security interest and rights created under the Security Agreement.
