RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), dated as of January 29, 2019, confirms the termination and release of the security interest granted by Bonanza Restaurant Company LLC, a Delaware limited liability company ("Grantor"), to FB Lending, LLC, a California limited liability company ("Grantee"), as set forth hereunder.

WHEREAS, this Release is intended to confirm the release and termination of all liens, security interests, and other encumbrances in and to the Trademarks created under the Security Agreement in favor of Grantee.

NOW, THEREFORE, pursuant to the terms of the Security Agreement:

1. This Release confirms that the entire security interest and all other rights and interests granted to Grantee under the Security Agreement in and to the Trademark Collateral and Trademarks are released and permanently terminated to the extent that any security interest was granted to Grantee by the Security Agreement.

2. This Release is intended to be recorded in the U.S. Patent and Trademark Office to confirm and evidence the foregoing release and termination of the security interest and rights created under the Security Agreement.
