1. Assignor on behalf of itself and its predecessors and successors in interest, hereby confirms the assignment and transfer to Assignee, all of Assignor’s right, title and interest in and to the Marks together with the goodwill of the business symbolized by the Marks and the right to recover for damages and profits and all other remedies for past infringements thereof, together with the assets of the business, which business is ongoing and existing.
2. Assignor hereby acknowledges that it retains no right to use the Marks and agrees not to challenge or assist others to challenge the validity, or Assignee’s ownership, of the Marks. Assignor covenants that no assignment, sale, agreement or encumbrance has been made or will be made or entered into by Assignor that would conflict with this Agreement.
3. Assignor further authorizes Assignee to proceed with the necessary recordal of this Assignment before the United States Patent and Trademark Office.
