RELEASE OF TRADEMARK SECURITY AGREEMENT

This RELEASE OF TRADEMARK SECURITY AGREEMENT ("*Release*") effective as of November 11, 2019 by SunTrust Bank (the "*Assignee*"), in favor of Halifax California, LLC, a Florida limited liability company ("*Halifax California*"), Halifax Sarasota, LLC, a Florida limited liability company ("*Halifax Sarasota*"), Halifax Alabama, LLC, a Florida limited liability company ("*Halifax Alabama*"), Halifax Lakeland, LLC, a Florida limited liability company ("*Halifax Lakeland*"), Halifax North Central Florida, LLC, a Florida limited liability company ("*Halifax Florida*"), Halifax South Carolina, LLC ("*Halifax South Carolina*"), a Florida limited liability company and Halifax Media Acquisition LLC, a Delaware limited liability company ("*Halifax Media Acquisition*"), and together with Halifax California, Halifax Sarasota, Halifax Alabama, Halifax Lakeland, Halifax Florida and Halifax South Carolina, the "*Grantors*").

WHEREAS, Grantors and LBC Credit Partners II, L.P., as Administrative Agent ("*LBC*") executed and delivered a Trademark Security Agreement, dated January 6, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Security Agreement*"), granting to LBC a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Trademarks (as defined in the Security Agreement), notice of which was recorded with the United States Patent and Trademark Office ("*USPTO*") on February 10, 2012, at Reel 4715, Frame 0303.

WHEREAS, all of LBC's right in and to the Security Agreement were assigned to Assignee pursuant to that certain Assignment and Acceptance and Agreement Regarding Agency Resignation, Appointment and Acceptance dated as of October 10, 2013.

WHEREAS, Assignee's security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided are hereby terminated, released and discharged fully; and

WHEREAS, Grantors have requested that Assignee provide a document suitable for recording with the USPTO to evidence the release of Assignee's security interests in and liens on the Trademarks as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby:

1. terminates the Security Agreement and releases, terminates and discharges fully all liens and security interests by Grantors in Assignee's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Release be recorded with the USPTO.
