

# ARTICLES OF MERGER OF RELIANT BANK AND COMMUNITY BANK & TRUST

Pursuant to applicable provisions of the Tennessee Banking Act, Tennessee Code Annotated § 45-1-101 et seq. (the "Banking Act"), and the Tennessee Business Corporation Act, Tennessee Code Annotated § 48-11-101 et seq. (the "Corporation Act"), the undersigned hereby adopt and submit the following Articles of Merger:

- 1. The parties to the Merger (as defined below) are Reliant Bank, a Tennessee-chartered banking corporation ("Reliant Bank"), and Community Bank & Trust, a Tennessee-chartered banking corporation ("Community Bank").
- 2. Pursuant to an Agreement and Plan of Merger dated September 16, 2019 (the "<u>Plan of Merger</u>"), by and between Reliant Bank and Community Bank, Community Bank will be merged with and into Reliant Bank (the "<u>Merger</u>"), with Reliant Bank to be the banking corporation to survive the Merger.
- 3. The Plan of Merger was adopted by the board of directors of Reliant Bank on September 16, 2019, approval of the Plan of Merger by the shareholder(s) of Reliant Bank not being required by Chapter 21 of the Corporation Act. The Plan of Merger was approved by the shareholder(s) of Reliant Bank on December 17, 2019, such approval being required by Chapter 2, Part 13 of the Banking Act.
- 4. The Plan of Merger was approved by the shareholder(s) of Community Bank on December 5, 2019, by the affirmative vote of the required percentage of all votes entitled to be cast, such approval being required by Chapter 2, Part 13 of the Banking Act and Chapter 21 of the Corporation Act.
- 5. These Articles of Merger, and the Merger, shall be effective as of 12:02 A.M., Central Time, on January 1, 2020.
