Pursuant to the provisions of Sec. 14-11-904 of the Georgia Limited Liability Company Act, the undersigned limited liability company and corporation hereby execute the following articles of merger and set forth the following:

1. The name and jurisdiction of each of the merging entities are:
  - (a) Apollo Marketing, LLC, a Georgia limited liability company ("Apollo"), and
  - (b) NB Products Inc., a Delaware corporation (the "Corporation").
2. The Corporation shall be the surviving entity into which Apollo is merging (the "Surviving Corporation"), and the name of the Surviving Corporation shall be "NB Products Inc."

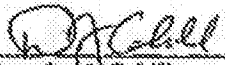
