**TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property (“Release”) is made as of February 6, 2020, by **KEYBANK NATIONAL ASSOCIATION**, a United States national association, (the “Collateral Agent”) in favor of **AMERICAN PACIFIC CORPORATION**, a Nevada corporation with an address at 10622 W 6400 N, Cedar City, Utah 84721, **AMERICAN PACIFIC CORPORATION**, a Delaware corporation, **FALMOUTH GROUP HOLDINGS CORP.**, a Delaware corporation, **CARPENTER INTERMEDIATE CORP.**, a Delaware corporation, **FLAMINGO PARENT CORP.**, a Delaware corporation, **ENERGETIC ADDITIVES INC., LLC**, a Nevada limited liability company, **AMPAC-ISP CORP.**, **AMERICAN AZIDE CORPORATION**, a Nevada corporation, and **AMPAC FARMS, INC.**, a Nevada corporation (collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into an Intellectual Property Security Agreement (the “IP Security Agreement”) dated December 14, 2015 with the Collateral Agent, notice of which was recorded on December 16, 2015 at the United States Patent and Trademark Office at Reel 5690, Frame 0942 and Reel 037312, Frame 0970. Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Grantors granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest in favor of the Collateral Agent, in and to all of its right, title and interest in, to and under its Intellectual Property Collateral, including without limitation the Copyrights, Patents and Trademarks listed in Schedule A (together with the Intellectual Property Collateral, the “Released Intellectual Property Collateral”).

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Released Intellectual Property Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby (i) terminates the IP Security Agreement, (ii) releases, terminates and discharges any and all of its interest in the Released Intellectual Property Collateral, and (iii) reassigns, transfers and conveys to Grantors any right, title and interest of the Collateral Agent in the Released Intellectual Property Collateral.
