WHEREAS, House Brewing, a California corporation (hereinafter, "House Brewing"), has adopted and is using the trademarks set forth in Schedule "A", attached hereto and incorporated herein by this reference (the "Trademarks");

WHEREAS, House Brewing entered into that certain Security Agreement, dated as of November 4, 2019 (hereinafter the "Security Agreement") with Britt Lovett, an individual as the Collateral Agent (as such term is defined in the Security Agreement) on behalf of the Secured Note Holders (as such term is defined in the Security Agreement), pursuant to which House Brewing assigned to Lovett as the Collateral Agent, as a part House Brewing's undertakings pursuant to the Security Agreement, a security interest in the Trademarks, and all goodwill associated therewith; and


WHEREAS, the Secured Note Holders have confirmed that the security interest in the Trademarks previously assigned by House Brewing has been terminated and released in all respects.

WHEREAS, an amendment to Britt Lovett's UCC Financing Statement was filed January 24, 2020, with the approval of Brittany Lovett, designating Humble Abode LLC, a California limited liability company as Collateral Agent on the Security Agreement.


