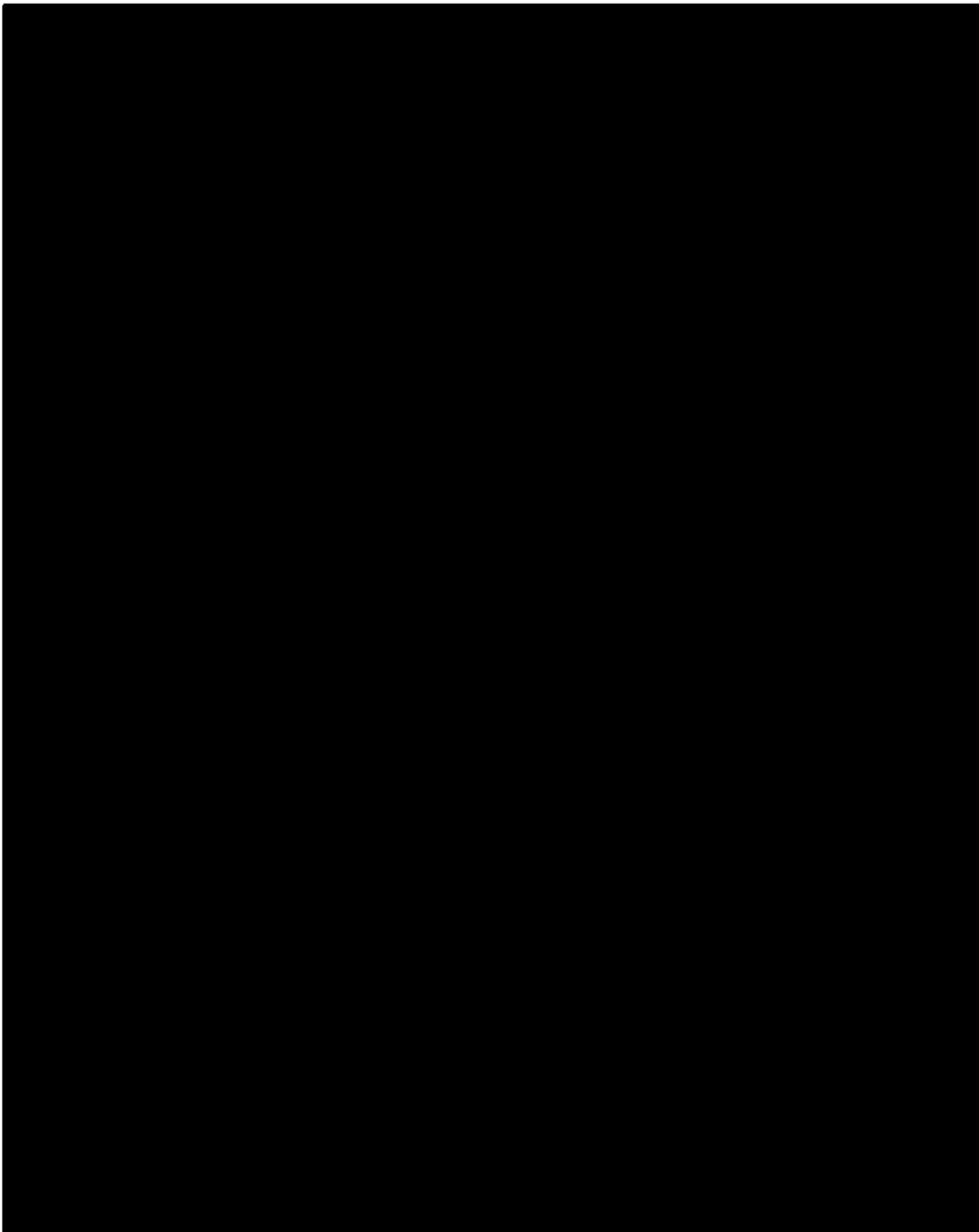
 the Assignor hereby assigns to the Assignee absolutely all its right, title and interest in and to the Assigned Rights, including:
