## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of February 7, 2020, and made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as Administrative Agent (the "Grantee"), to **INNOPHOS, INC.**, a Delaware corporation, **AMT LABS, INC.**, a Delaware corporation and **KELATRON CORPORATION**, a Utah corporation, (the "Grantors").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of August 27, 2010 by the Grantors in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantors to the Grantee in certain collateral, including the Trademarks as presented in Schedule 1 of the Security Agreement;

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on January 14, 2013 at Reel/Frame 004942/0588; and corrected<sup>1</sup> on February 4, 2020 and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications re-listed on Schedule A hereto.


2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its lien on and security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.

<sup>1</sup> The recording of the Security Agreement was corrected on February 4, 2020, to reflect that the proper entity holding the security lien is "Wells Fargo Bank, National Association" and not "Wells Fargo Bank" as inadvertently provided in the recordation on January 14, 2013, at Reel/Frame 004942/0588. At the time of the execution of this Termination, the Reel/Frame of the corrected document filed on February 4, 2020, was unavailable.
