TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of February 7, 2020, and made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as Administrative Agent (the "Grantee"), to **NUTRAGENESIS, LLC**, a Vermont limited liability company, **ICON GROUP, LLC**, a Vermont limited liability company and **TRADEWORKS GROUP, INC.**, a Delaware corporation (the "Grantors").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of January 17, 2018 by the Grantors in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantors to the Grantee in certain collateral, including the Trademarks as presented in Schedule 1 of the Security Agreement;

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on January 19, 2018 at Reel/Frame 6253/0887;

WHEREAS, the Security Agreement was recorded at the Innovation, Science and Economic Development Canada – Canadian Intellectual Property Office on February 27, 2018 as File Number 1662780; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:


1. Definitions. The term "Trademarks" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications re-listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its lien on and security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office and also with the Innovation, Science and Economic Development Canada – Canadian Intellectual Property Office.
