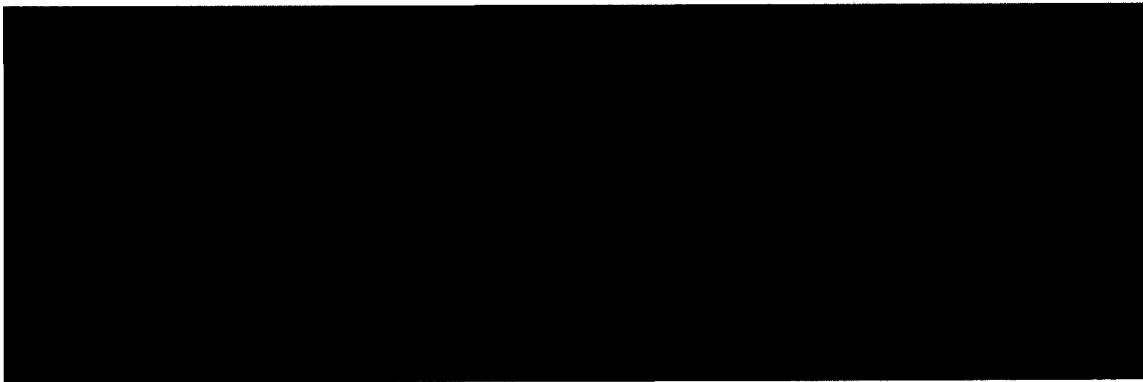

TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), dated as of October 6, 2015 is entered into by and between 3M Company, a Delaware corporation ("Seller"), and Bibliotheca RFID Library Systems AG, a stock corporation (*aktiengesellschaft*) incorporated under the laws of Switzerland, having its official seat in Risch, Switzerland, its registered office address at Erlenstrasse 4A, 6343 Rotkreuz, Switzerland, and registered with the commercial register of Zug under company number CHE-109.545.648 ("Buyer" and, together with Seller, the "Parties").

RECITALS



WHEREAS, this Agreement is an Ancillary Agreement pursuant to the USCC Business APA;

WHEREAS, this Agreement is being entered into by the Parties as a condition and mutual inducement to the Closing; and

WHEREAS, pursuant to the USCC Business APA, Buyer has agreed to purchase and accept and Seller has agreed to sell, transfer, convey and assign to Buyer all of Seller's right, title and interest in and to the trademark registrations and applications identified in Appendix A hereto (the "Trademarks").

NOW, THEREFORE, in consideration of the mutual agreements, covenants and other premises set forth herein and in the USCC Business APA and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and accepted, the Parties agree as follows:

1. Assignment. Seller does hereby sell, assign and transfer unto Buyer all of Seller's right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, including, without limitation, the right to sue for all past, present and future infringement and dilution thereof, to settle, collect and retain all proceeds from any such actions including royalties, damages, costs and attorney's fees, all said rights to be held and enjoyed by Buyer for its own use and enjoyment and for the use and enjoyment of its

successors and assigns to the full end of the term for the Trademarks as fully and entirely as the same would have been held by Seller had this assignment and sale not been made.

2. Cooperation. This Agreement has been executed and delivered by Seller for the purpose of recording the assignment herein with the appropriate Governmental Body. Seller agrees to execute and deliver to Buyer, at Buyer's sole cost and expense, such further assignments and related documents with respect to the Trademarks, as Buyer shall reasonably request to vest the title to the Trademarks in the name of Buyer or its designee.

3. Warranties. EXCEPT AS EXPRESSLY SET FORTH IN THE USCC BUSINESS APA, THERE ARE NO EXPRESS OR IMPLIED WARRANTIES OF NONINFRINGEMENT OF THIRD PARTY INTELLECTUAL PROPERTY RIGHTS, OR REGARDING THE SCOPE, VALIDITY, TITLE OR ENFORCEABILITY OF ANY TRANSFERRED INTELLECTUAL PROPERTY.

4. General Provisions. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed thereto in the USCC Business APA. This Agreement, Appendix A hereto and the USCC Business APA constitute the sole and entire agreement of the Parties with respect to the subject matter contained herein and therein, and supersede all other prior representations, warranties, understandings and agreements, both written and oral, with respect to such subject matter. Notwithstanding any other provision of this Agreement to the contrary, in the event and to the extent that there shall be a conflict between the provisions of this Agreement and the provisions of the USCC Business APA, the provisions of the USCC Business APA shall control (unless this Agreement expressly provides otherwise). This Agreement shall not be amended, modified or supplemented except by an instrument in writing specifically designated as an amendment hereto and executed by each of the Parties. Neither any course of conduct or failure or delay of any Party in exercising or enforcing any right, remedy or power hereunder shall operate or be construed as a waiver thereof, nor shall any single or partial exercise of any right, remedy or power hereunder, or any abandonment or discontinuance of steps to enforce such right, remedy or power, or any course of conduct, preclude any other or further exercise thereof or the exercise of any other right, remedy or power. This Agreement shall be binding upon and inure solely to the benefit of each Party and its successors and permitted assigns. This Agreement may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and both of which together will constitute one and the same instrument.

5. Governing Law. This Agreement and all matters arising out of or relating to this Agreement or any of the transactions contemplated hereby, including all rights of the Parties (whether sounding in contract, tort, common or statutory law, equity or otherwise), shall be interpreted, construed and governed by and in accordance with the internal Laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Law of any jurisdiction other than those of the State of Delaware.
