TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Trademark Security Agreement") is made this 7th day of February, 2020, by and between ORGANICGIRL, LLC, a Delaware limited liability company ("Grantor"), and DIRECT PACK, INC., a Delaware corporation ("Secured Party").

WITNESSETH:

WHEREAS, pursuant to that Secured Promissory Note dated as of December 6, 2019 (as amended, restated, supplemented, or otherwise modified from time to time, the "Secured Promissory Note"), by and between Grantor and Secured Party, Secured Party made certain financial accommodations available to Grantor on the terms and conditions thereof; and

WHEREAS, in connection with the Secured Promissory Note, the Grantor granted the Secured Party a security interest in certain of its intellectual property, and the parties have agreed to desire to enter into this Trademark Agreement;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. DEFINED TERMS. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Secured Promissory Note.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL. Grantor hereby grants to Secured Party a security interest in all of its right, title and interest (referred to in this Trademark Security Agreement as the "Security Interest") in all of the following, whether now owned or hereafter acquired or arising (collectively, the "Trademark Collateral"):

(a) all of its trademarks, servicemarks, trade names, trade styles, trademark and service mark applications, and licenses and rights to use any of the foregoing, and all applications, registrations and recordings relating to any of the foregoing as may be filed with the United States Patent and Trademark Office, including those referred to on Schedule I;

(b) all rights and privileges arising under applicable law with respect to Grantor's use of the foregoing;

(c) all extensions, renewals, reissues, divisions, continuations and continuations-in-part of any of the foregoing;

(d) all rights to sue for past present and future infringement of any of the foregoing;

(e) any goodwill associated with any trademark or servicemark, or the license of any trademark or servicemark;

(f) additions, accessions and substitutes to and for all of the foregoing; and

(g) all books and records related to the foregoing.

3. SECURITY FOR SECURED OBLIGATIONS. This Trademark Security Agreement and the Security Interest created hereby secures the payment of principal of, and interest on, the Secured Promissory Note when due.

4. SECURITY AGREEMENT. The Security Interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interests granted to Secured Party pursuant to the Secured Promissory Note. To the extent there is any inconsistency between this Trademark Security Agreement and the Secured Promissory Note, the Secured Promissory Note shall control.

5. RECORDATION. Grantor authorizes the Commissioner for Trademarks and any other government officials to record and register this Trademark Security Agreement with the United States Patent and Trademark Office upon request by Secured Party.

6. AUTHORIZATION TO SUPPLEMENT. If Grantor shall obtain rights to any new trademarks, the provisions of this Trademark Security Agreement shall automatically apply thereto. Promptly upon request from Secured Party, and from time to time, but not more frequently than on a quarterly basis in respect of a calendar year, Grantor shall use its reasonable efforts to notify Secured Party in writing Secured Party with respect to any such new trademarks or renewal or extension of any trademark registration. Grantors hereby agree to cooperate with Secured Party to permit Secured Party to update, modify or supplement this Trademark Security Agreement by amending Schedule I to include any such new trademark rights of Grantor. Notwithstanding the foregoing, no failure to so modify this Trademark Security Agreement or amend Schedule I shall in any way affect, invalidate or detract from Secured Party's continuing security interest in all Collateral, whether or not listed on Schedule I.

7. GOVERNING LAW. THIS TRADEMARK SECURITY AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF GRANTOR AND SECURED PARTY UNDER THIS TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF CALIFORNIA, WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES THEREOF THAT WOULD APPLY THE LAWS OF ANOTHER JURISDICTION. ALL DISPUTES AND CONTROVERSIES ARISING OUT OF OR IN CONNECTION WITH THIS TRADEMARK SECURITY AGREEMENT SHALL BE RESOLVED EXCLUSIVELY BY THE STATE AND FEDERAL COURTS LOCATED IN THE STATE OF CALIFORNIA AND SECURED PARTY AND GRANTOR AGREE TO SUBMIT TO THE EXCLUSIVE JURISDICTION OF SAID COURT.
