RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Trademark Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 14, 2019, at Reel 006563 and Frame 0572 and at Reel 006563 and Frame 0579; and

WHEREAS, the Bank has agreed to release its security interest in the Released Trademarks.

NOW, THEREFORE, for valuable consideration:

The Bank hereby terminates and releases its security interest in the Released Trademarks, and the Bank hereby assigns and transfers to Grantors, without any representation, warranty, or recourse whatsoever, the Bank’s entire right, title, and interest in and to the Released Trademarks, effective as of the date set forth above.
