Pursuant to Title 8, Section 264 of the Delaware General Corporation Law (the "DGCL"), the undersigned hereby certifies to the following information relating the merger of Big Time Decor LLC with and into NB Products Inc. (the "Merger")

FIRST: That the name and jurisdiction of formation of each of the entities proposing to merge (the "Constituent Entities") are:
