**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this "*Termination and Release*") is granted as of February 11, 2020 by **ROCKLAND TRUST COMPANY** (as successor to Blue Hills Bank) (the "*Lender*"), in favor of **FRANKLIN PAINT COMPANY, INC.**, a Massachusetts corporation (the "*Grantor*"),

WHEREAS, the Grantor executed and delivered a Grant of Security Interest in United States Trademarks dated as of December 27, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"), granting the Grantee a security interest in and lien on (i) all of the Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the "*Trademarks*") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Trademarks, (iii) the goodwill of the businesses with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same (all of the foregoing, collectively, the "*Trademark Collateral*"), which Grant was recorded with the United States Patent and Trademark Office ("*USPTO*") on December 28, 2017 at Reel 6237, Frame 0600;

WHEREAS, the Grantor has requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on the Trademark Collateral as herein provided; and

WHEREAS, the Grantor has requested that the Grantee provide a document suitable for recording with the USPTO to evidence the release of the Grantee's security interests in and liens on the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the grants and releases, terminates and discharges all liens and security interests in the Grant, all right, title and interest in, to and under the Trademark Collateral, including the United States trademarks, trademark registrations and trademark applications set forth on Schedule A attached hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
