Assignor shall have no duty to defend the Assignee or the Registered Marks and shall not be liable under any legal or equitable theory for any direct, indirect, special incidental, consequential, punitive or exemplary damages of any kind in connection with this Agreement or the Assigned Marks even if the Assignee has been advised of the possibility of such damages.

Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable act Assignee may require in order to vest in Assignee all Assignor's right, title, and interest in and to the Registered Marks. Notwithstanding the foregoing, Assignee shall be exclusively responsible for any fees, costs, expenses or payments to third parties arising from such efforts.
