TERMINATION OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION OF TRADEMARK SECURITY AGREEMENT**, effective as of February 3, 2020, is made by **MIDCAP FINANCIAL TRUST**, as administrative agent (the "Secured Party"), in favor of **SILICON 360, LLC**, a Delaware limited liability company ("Debtor"), with an address of 801 Buckeye Court, Milpitas, CA 95035.

WHEREAS, pursuant to that certain Credit and Guarantee Agreement dated as of August 7, 2017 (as may have been amended from time to time, the "Credit Agreement") and the Trademark Security Agreement dated August 7, 2017 (the "Trademark Security Agreement"), Debtor granted to Secured Party a continuing security interest in all of Debtor's right, title and interest in, to and under all Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademarks listed in Schedule A.

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on August 7, 2017 at Reel 6124 and Frame 0091.

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates and releases all liens and security interests in the Trademark Collateral, including, without limitation, the trademarks listed in Schedule A.

THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES OTHER THAN SECTION 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW.
