**TERMINATION AND RELEASE OF
SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS (this "Termination and Release") is made as of February 13, 2020 by SILICON VALLEY BANK ("Bank") in favor of Proxibid, Inc., a Nebraska corporation ("Proxibid") and Auction Payment Network, LLC, a Nebraska limited liability company ("Auction Payment") and together with Proxibid, each individually and collectively, jointly and severally, "Grantor").

WHEREAS, Grantor executed and delivered that certain Intellectual Property Security Agreement, dated as of September 29, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "IP Security Agreement"), granting Bank a security interest in and lien on Grantor's Intellectual Property Collateral described therein, which was recorded with the United States Patent and Trademark Office ("USPTO") on October 4, 2016 at Reel 005893, Frame 0209 and the United States Copyright Office ("USCO") on October 5, 2016 with Document Number V9942D382.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interest in and liens and all right, title and interest of Grantor in, to and under all of the Intellectual Property Collateral as herein provided; and

WHEREAS, Grantor has requested that Bank provide a document suitable for recording in the USPTO and USCO to evidence the release of Bank's security interests in and liens on the Intellectual Property Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby agrees as follows:

1. **Definitions.** Capitalized terms not defined herein have the meanings set forth in the IP Security Agreement.
2. **Release of Security Interest.** The Bank, without representation or warranty, hereby terminates, cancels and releases any and all security interest it has in the Intellectual Property Collateral and all intellectual property and goodwill associated therewith, including, but not limited to, the intellectual property identified on Schedule I hereto.
3. **Recordation.** Bank authorizes Grantor and its designees to record this Termination and Release with the USPTO, the USCO and any similar office or agency of any other country or political subdivision, as applicable.
