RESTATED CERTIFICATE OF INCORPORATION

BNY Mellon Asset Management North America Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted a resolution proposing and declaring advisable the following amendment to the Restated Certificate of Incorporation of the Corporation:

RESOLVED, that the Restated Certificate of Incorporation of BNY Mellon Asset Management North America Corporation be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:

"First: The name of the Corporation is Mellon Investments Corporation."
