CONFIRMATORY SECURITY AGREEMENT

WHEREAS NATIONAL BANK OF CANADA (the "**Creditor**") and Tecsys Inc., Logi D Inc., Logi D Holding Inc. and OrderDynamics Corporation (collectively, the "**Grantors**", and as the context requires "**Grantor**") entered into a certain deed of hypothec bearing formal date of January 30, 2019, as same may be amended, supplemented, restated, replaced or otherwise modified from time to time (the "**Deed of Hypothec**"), pursuant to which the Grantors hypothecated in favour of the Creditor, among other things, the universality of all the intellectual property now owned or held by such Grantor or of which it is an authorized user or which such Grantor shall hereafter become an authorized user, together with all of such Grantor's rights, titles and interests therein (collectively, the "**Intellectual Property**").

WHEREAS the Creditor and OrderDynamics Corporation and Tecsys Inc. entered into a certain general security agreement dated as of January 30, 2019, as same may be amended, supplemented, restated, replaced or otherwise modified from time to time (the "**GSA**"), pursuant to which such Grantor granted in favour of the Creditor a security interest in, among other things, the Intellectual Property.

WHEREAS the Grantors are the registered owner of the Intellectual Property listed in Schedule "A" hereto.


WHEREAS the Grantors and the Creditor are desirous of recording the security created in the Intellectual Property under the Deed of Hypothec and the GSA with the United States Patent and Trademark Office.

NOW THEREFORE, the parties agree that this Confirmatory Security Agreement has been executed by the parties hereto for purposes of being recorded with the United States Patent and Trademark Office.


