FURTHER, ASSIGNOR hereby covenants and agrees to execute and deliver, at the request of ASSIGNEE, such further instruments of transfer and confirmatory assignment in recordable form and to take any other lawful action as such ASSIGNEE may reasonably request to more effectively consummate the assignments contemplated by this Assignment. Specifically, ASSIGNOR agrees to, upon the request and at ASSIGNEE's expense, execute, acknowledge and deliver such further documents, instruments, conveyances and assurances and take such further actions as may be reasonably required to register and/or to vest record title of said respective registrations in the name of ASSIGNEE the assignment of any of the TRADEMARKS herein assigned in any appropriate governmental agency or registrar.


This Assignment may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, and all counterparts together shall constitute a single agreement.






