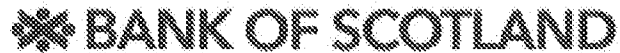

RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is made as of February 17, 2020 ("Effective Date") by Bank of Scotland plc (the "Lender"), to Clyde Union Inc., f/k/a as Union Pump Company (the "Grantor"), as follows:

WHEREAS, Union Pump Company and Bank of Scotland plc. entered into a Collateral Assignment for Security (the "Security Agreement") dated as of November 12, 2008,

WHEREAS, pursuant to the Security Agreement, Union Pump Company granted to bank of Scotland plc. a security interest (the "Security Interest") in all right, title and interest of Union Pump Company in and to the Trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on December 12, 2008 at reel 3902 frames 0107-0113;


WHEREAS, the Grantor is a successor in interest of Union Pump Company;

WHEREAS, the Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Trademarks; and

WHEREAS, the Lender wishes to release its security interest in the Trademarks listed in Schedule A.

NOW THEREFORE, in view of the foregoing:

1. Release of Lien. The Lender hereby (i) unconditionally, irrevocably and absolutely terminates, extinguishes, cancels, releases and forever discharges the Security Interest and any of its right, title and interest in or to the Trademark granted pursuant to the Security Agreement, (ii) terminates the Security Agreements, and (iii) reassigns, without any representation or warranty of any kind whatsoever, to the Grantors any and all right, title and interest (if any) that the Lender may have held in or to any of the Trademark.
2. Authorization to Record. The Lender authorizes and requests that the United States Patent and Trademark Office (the "USPTO") and any applicable government office record this Release.
