## **RELEASE OF TRADEMARKS**

THIS RELEASE OF TRADEMARKS dated as of February 1, 2020 (this "Release") is made by Madison Capital Funding LLC, with an address of 227 West Monroe Street, Suite 5400, Chicago, Illinois 60606, acting in its capacity as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of February 21, 2017 (the "Trademark Security Agreement") by and between Crafts Group, LLC (the "Grantor") and the Agent.


WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on February 21, 2017 at reel 5994, frame 0226, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks described on Schedule 1 attached hereto (the "Released Trademarks"); and

WHEREAS, the Grantor has requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Trademarks, (b) release its security interest in the Released Trademarks, and (c) discharge any and all right, title and interest it has in and the security interest granted to Agent in the Released Trademarks; provided that such release shall not affect either (i) the Trademark Security Agreement, or (ii) the security interest granted to the Agent in the remaining Trademark Collateral covered in the Trademark Security Agreement, all of which, in each case, remain in full force and effect. Agent agrees to take such further actions, and provide to the Grantor and its successors, assigns and legal representatives such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release, all at the Grantor's sole expense.
