NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment ("Assignment") is entered into and effective as of August 29, 2016 (the "Effective Date"), by and between Empower Software Solutions, Inc., a Delaware corporation located at 315 East Robinson Street, Suite 450, Orlando, Florida 32801 ("Assignor") and Federal Liaison Services LLC, a Delaware limited liability company located at One ADP Boulevard, Roseland, New Jersey 07068 ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. **Assignment**. Assignor hereby confirms that it assigns, transfers, sells, conveys, and delivers to Assignee nunc pro tunc effective as of August 29, 2016, all right, title and interest in and to the EMPOWER TAX Mark throughout the world, including, without limitation, the trademark registration pertaining thereto and all common law rights therein, together with all goodwill arising from the use of and symbolized by the EMPOWER TAX Mark, including all rights to sue or otherwise assert the EMPOWER TAX Mark and to recover damages, profits and/or other compensation for past, present and future infringements, the right to license the EMPOWER TAX Mark to others, and the right to renew the trademark registration for the EMPOWER TAX Mark, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, to be used as fully and entirely as said rights would have been held and enjoyed by Assignor had this assignment not made.

2. **Authorization to Record**. Assignor hereby authorizes Assignee to record this Assignment in the relevant trademark offices throughout the world.
