**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”) is made as of February 18, 2020 (the “Effective Date”) by Delaware Trust Company, in its capacity as collateral agent for the Secured Parties (in such capacity, “Collateral Agent”), in favor of Flexi-Van Leasing, LLC (formerly known as Flexi-Van Leasing, Inc.), a Delaware limited liability company (the “Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below) or, if not defined therein, in the Trademark Security Agreements (as defined below).

WHEREAS, reference is made to that certain Second Lien Pledge and Security Agreement, dated as of February 16, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), made by Issuer and the other Grantors party thereto in favor of Collateral Agent;

WHEREAS, pursuant to the Security Agreement, the Grantor and Collateral Agent entered into (i) that certain Trademark Security Agreement, dated as of February 16, 2018, which was recorded with the United States Patent and Trademark Office, (the “USPTO”) on February 19, 2018 at Reel 6273, Frame 0222; and (ii) that certain Trademark Security Agreement, dated as of January 11, 2019, which was recorded with the USPTO on January 14, 2019 at Reel 6523, Frame 0588 (each as amended, restated, supplemented or otherwise modified from time to time, collectively, the “Trademark Security Agreements”);

WHEREAS, pursuant to the terms of the Trademark Security Agreements, the Grantor granted, assigned, and pledged to Collateral Agent, for the benefit of the Secured Parties, to secure the Obligations, a continuing security interest in all of the Grantor’s right, title, and interest in and to all of its trademarks, whether then owned or thereafter acquired or arising, including without limitation those trademarks listed on **Schedule I** attached hereto (the “Trademark Collateral”); and

WHEREAS, Collateral Agent now desires to release and terminate its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby covenants and agrees, as follows, to terminate, release, and, discharge its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreements, and reassign to the Grantor all right, title, and interest that Collateral Agent may have in the Trademark Collateral pursuant to the Trademark Security Agreements. Collateral Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record this Release.

Collateral Agent executes and delivers this Release without any recourse, representation, warranty or liability whatsoever.
