CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Assignment (the "Assignment"), which is effective as of November 18, 2019, is by and between Rochester Shoe Tree Co., Inc., a corporation formed under the laws of the State of Delaware, with an address of One Cedar Lane, Ashland, New Hampshire 03217 ("Assignor") and Moneysworth & Best U.S.A., Inc., a corporation formed under the laws of the State of Illinois, with an address of 120 Midair Court, Brampton, Ontario, Canada L6T 5V1 ("Assignee"). Assignor and Assignee are referred to collectively as the "Parties" and individually as a "Party".

WHEREAS, the Parties entered into an Asset Purchase Agreement dated October 22, 2019 and a Bill of Sale dated November 18, 2019 (the "BOS"), in which the Assignor assigned certain assets to Assignee, including the trademarks listed in Schedule A for the services listed in Schedule A (the "Marks"), the trademark registrations listed in Schedule A (the "Registrations"), and the goodwill of Assignor's business symbolized thereby (the Marks, the Registrations, and the goodwill are collectively referred to herein as the "Trademarks").

WHEREAS, the Parties desire to confirm the assignment of the Trademarks in this Assignment;

NOW, THEREFORE, in consideration of the premises and agreements contained herein, the receipt and sufficiency of which is hereby acknowledged, the Parties confirm and agree as follows:

1. **Assignment.** As of November 18, 2019 in the BOS, Assignor assigned, transferred, granted, conveyed, and relinquished to Assignee all right, title, and interest in and to the Trademarks, including, but not limited to, the right to sue for and recover damages with respect to past infringements of the Trademarks, as fully and completely as permitted by law, it was the intention of the Parties that Assignee shall have acquired all rights in the Trademarks, leaving Assignor with no rights whatsoever.
