## **INTELLECTUAL PROPERTY TERMINATION AND RELEASE**

THIS INTELLECTUAL PROPERTY TERMINATION AND RELEASE is made as of February 18, 2020, by Antares Capital LP ("Antares Capital"), as administrative agent for the Lenders and the L/C Issuers (in such capacity, "Agent") in favor of PrimeSport, Inc., Anthony Travel, LLC, GoTickets, Inc., Steve Furgal's International Tennis Tours, CID Entertainment, LLC and Curadora, LLC (each a "Grantor" and, collectively, the "Grantors"). Capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the IP Security Agreement (as defined below).

### **W I T N E S S E T H:**

WHEREAS, Grantors, the other grantors from time to time party thereto and the Agent entered into that certain Guaranty and Security Agreement dated as of September 29, 2016 (as amended, modified, restated and/or supplemented from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantor and Agent entered into that certain Intellectual Property Security Agreement dated as of September 29, 2016 (the "IP Security Agreement"), in each case, pursuant to which each Grantor mortgaged, pledged and hypothecated to Agent, for the benefit of the Secured Parties, and granted to the Agent for the benefit of the Secured Parties a Lien on and security interest in all of each Grantor's right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising (collectively the "Trademark Collateral"):

- (a) all of its Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation those referred to on Schedule 1 hereto;
- (b) all renewals and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- (d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on December 12, 2017 at Reel 6226, Frame 0083; and

WHEREAS, each Grantor has requested that Agent terminate and release Lien on and its security interest in the Trademark Collateral and reassign any and all rights in the same to such Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby, without any representation, warranty, recourse or undertaking by Agent, releases, cancels and terminates in its entirety its Lien on and its security interest in all of each Grantor's right, title and interest in, to and under the Trademark Collateral.

2. Agent hereby discharges, quit claims, and relinquishes unto each Grantor, reassigns, grants, re-transfers and re-conveys to Grantors, without any representation, warranty, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademark Collateral, and authorizes the recordation of this Intellectual Property Termination and Release with the United States Patent and Trademark Office at the expense of the Credit Parties.

3. The Agent agrees to take all further actions, and provide to each Grantor, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at the sole cost and expense at the expense of the Credit Parties, to more fully and effectively effectuate the purposes of this Intellectual Property Termination and Release.

4. This Intellectual Property Termination and Release is entered into in conjunction with, and not in lieu of, that certain Payoff Letter dated as of February 18, 2020 by and between the Agent, the Credit Parties and other parties thereto.

5. This Intellectual Property Termination and Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
