TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (“**Trademark Assignment**”), dated as of February 18, 2020, is made by and between North Carolina Wildlife Federation, Inc. (“**Assignee**”) and Dr. Angelique Hjarling (“**Assignor**”).

WHEREAS, under the terms of that certain Settlement Agreement dated February 18, 2020, Assignor has conveyed, transferred, and assigned to Assignee certain intellectual property of Assignor, and has agreed to execute and deliver this Trademark Assignment, for recording with the United States Patent and Trademark Office;

NOW THEREFORE, Assignor agrees as follows:

Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee any and all of Assignor’s rights, title and interest in and to the THE BUTTERFLY HIGHWAY mark, whether stylized, with design, or in standard characters (collectively, the “**Mark**”), along with any and all pending applications and registrations for the Mark, including without limitation U.S. Serial No. 88/328,464 (the “**Application**”), together with the goodwill of the business symbolized by the Mark.

Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by Assignee. Following the date hereof, upon Assignee’s reasonable request, and at Assignee’s sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Assigned Trademarks to Assignee, or any assignee or successor thereto.





